THE TENTH SOUTHEASTERN CONSORTIUM for Continuing Medical Education in Dermatology will be held at the Medical College of Virginia, Virginia Commonwealth University in Richmond, Virginia on Friday, Saturday and Sunday, October 24-26. The educational goal of the Consortium is to update one to two areas of clinical dermatology at each meeting. Topics are selected by the Steering Committee from the list of the Core Curriculum and rotate every year among the participating institutions. The complete curriculum is recycled every eight years. After selection of each broad topic, speakers are carefully chosen for each subject. Emphasis is put on choosing effective and enthusiastic teachers from the area encompassed by the Consortium.

THE TOPIC THIS YEAR: "Update on Acne and Acne-Like Diseases and Disorders of Hair"

MEETING PLACE: Medical College of Virginia, Virginia Commonwealth University, Richmond, Virginia. The Friday and Saturday meetings will be held in the main auditorium of the Academy of Medicine building which is next door to the University Hospital. The Saturday evening dinner will be held in the Banquet Hall of the same building. On Sunday morning patients will be seen in Room 700 of the Nelson Clinic Building (7th Floor). Formal discussion of the clinical cases will take place immediately following the patient viewing in Sanger Hall, Room 1044.

HERBERT Z. LUND LECTURESHIP: Dr. Wilma F. Bergfeld, Professor and Chief of Dermatopathology at the Cleveland Clinic and a noted researcher in alopecia and hair disorders will give the Herbert Z. Lund lecture at 8:00 a.m. on Saturday morning, entitled "Alopecia in Women."

SPECIAL CLINICAL LECTURE: Dr. James J. Leyden, Professor of Dermatology at the University of Pennsylvania will deliver a special lecture at 3:30 on Friday afternoon entitled "How Antibiotics Work in the Treatment of Acne".

CLINICAL MEETING: All Consortium meetings are held in conjunction with the presentation of patients at a clinical meeting. Patients will be presented Sunday, October 26th, beginning at 8:30 a.m. in Room 700 of the Nelson Clinical Building (7th Floor).

TRANSPORTATION: The Southeastern Consortium meeting will be held at the Medical Center of the Medical College of Virginia. Fortunately, this quarter of Richmond is very attractive and an active tourist area. A market district, multiple restaurants, and a wide choice of hotel accommodations are all within walking distance to the Medical Center. The Market Street Hotel where most of the participants in the Southeastern Consortium meeting is within easy walking distance to the Medical Center. Therefore, no special transportation arrangements have been made.
